

OPEN LETTER RE: MY HUNGER STRIKE TO BEGIN ON:

MARCH 23, 2016

TO: DEPUTY WARDEN OPERATIONS, MR. OPPY.

I, [REDACTED] SUFFERING FROM MEDICAL CONDITIONS THAT IS CAUSING ME CONSTANT ILLNESS, DISCOMFORT, & SEVERE PAIN. ON NUMEROUS OCCASIONS I'VE COMPLAINED OF MY CONDITIONS AND SOUGHT MEDICAL ATTENTION. HOWEVER, MY COMPLAINTS & EFFORTS HAVE BEEN ALL BUT TOTALLY DISREGARDED. I FEAR THAT MY HEALTH IS DETERIORATING IMMENSELY AND I ALSO FEAR THAT MY HEALTH IS OF INSIGNIFICANCE TO "SOLC" MEDICAL DEPARTMENT. THEREFORE, I'M FORCED TO RESORT TO DRASTIC MEASURES, WHICH ENTAIL EMPLOYING A HUNGER STRIKE THAT I WOULD SERIOUSLY RATHER NOT SUBJECT MYSELF TO. MY ONLY CONCERN IS MY HEALTH. YET, IT IS NOT BEING ADEQUATELY ATTENDED TO. I SHALL BEGIN A HUNGER STRIKE THAT I WILL REMAIN ON UNTIL "SOLC" PROVIDES ME WITH ADEQUATE MEDICAL CARE THROUGH, TO SEND ME TO AN OUTSIDE HOSPITAL TO HAVE MY U.I. TRACT EXAMINED, REFER ME TO SPECIALISTS, WHO ARE BETTER QUALIFIED TO MEET MY MEDICAL NEEDS, & TO ORDER DIAGNOSTIC TESTS TO FURTHER IDENTIFY THE CAUSE OF MY CONDITIONS AS A WHOLE. ALSO, AFFORD ME AN APPROPRIATE DIET FOR MY WEIGHT LOSS & MALNUTRITION, E.G., ENSURE, ETC., & PRESCRIBE ME W/ EFFECTIVE PAIN MEDICATION & ANY & ALL MEDICATION FURTHER NECESSARY TO GIVE ME RELIEF. - OR AN OUTSIDE HOSPITAL IS FORCED TO PROVIDE IT. I HAVE NOTIFIED MY FAMILY AND SUPPORT SYSTEM OF MY CONDITION AND THE METHOD IN WHICH I PLAN TO EMPLOY. WE ALL ARE AWARE OF THE DANGERS OF THIS METHOD. BUT SEE NO OTHER REMEDY DUE TO "SOLC'S" FAILURE TO ACT. I AM NOT SUICIDAL; NOR DO I WISH TO HURT MYSELF, BUT I SEE NO OTHER OPTION. I NEED IMMEDIATE MEDICAL ATTENTION.'
