ON FEBRUARY 15<sup>TH</sup>, 2008, THE SOUTHPORT FACULTY MEDIA REVIEW COMMITTEE REJECTED AND CENSORED MY PUBLICATION "UNDER LOCK AND KEY, NOVEMBER 2007" #1 PAGES 1-12, IMPROPERLY CLAIMING THAT IT "INCITES DISOBEDIENCE".

THE SOUTHPORT FACULTY MEDIA REVIEW COMMITTEE REJECTION OF MY PUBLICATION (UNDER LOCK AND KEY NOVEMBER 2007 #1) VIOLATED MY FIRST AMENDMENT FREEDOM OF SPEECH AND FREEDOM OF PRESS RIGHT BASED ON THE FACT THAT MY PUBLICATION DOES NOT POSE ANY TYPE OF THREAT OR VIOLENCE, WITH RESPECT TO THE PEDAGOGICAL INTERESTS AND SECURITY OF THIS INSTITUTION; THEREFORE THE SOUTHPORT MEDIA REVIEW COMMITTEE DECISION TO REJECT MY PUBLICATION WAS "NOT" JUSTIFIED BY ANY PEDAGOGICAL INTEREST, TRUTHFULLY SPEAKING!! MY PUBLICATION "UNDER LOCK AND KEY, NOVEMBER 2007" #1, PAGES 1-12 IS A POLITICALLY - MOTIVATED PUBLICATION.

POLITICALLY - MOTIVATED CENSORSHIP IS UNCONSTITUTIONAL ACCORDING TO THE U.S. CONSTITUTION.

MY PUBLICATION "UNDER LOCK AND KEY", NOVEMBER 2007<sup>#1</sup>, PAGES 1-12, DOES NOT PROMOTE VIOLENCE OR ANY ACTIVITY THAT WOULD LEAD TO A SECURITY BREACH.

In fact, MY PUBLICATION "UNDER LOCK AND KEY", NOVEMBER 2007<sup>#1</sup>, PAGES 1-12, ACTUALLY PROMOTES REHABILITATION OF ME AND OTHER INMATES THROUGH POLITICAL CONSCIOUS THINKING.
