02 ***Alleges he has not received his news letters.

Summary of Facts:

laod - Inmate complains that "Newsletters" were not received and that he has not been sent a notice of non-delivery for newsletters. He sends an enclosure that is alleged to be from MIM for unconfirmed mail dating from 1/10/15 to 6/1/16. In reading the enclosure, inmate is supposed to fill out the form and send it back. It also indicates that inmate had been asking about articles that he had written and which issues they were published in. Both WCI and CCI have policies specifying the process for inmates to follow if they are seeking to publish their works. Mr. Meli confirms that he did not have permission to publish from WCI and inmate does not have permission to publish from CCI.

This complaint might have been intended for all 10 newsletters listed in the MIM document. However, inmate claim was originally interpreted to be addressing only the most recent May 2016 Under Lock and Key 50. Inmate provides no details in his complaint leaving the evidence to fill in factual gaps. There are problems with the evidence as it does not provide subscription: information, value or specific times that the 2 issue 50's were sent. Presumably one issue was sent to inmate at WCI just after his transfer to CCI and the other is supposed to have been sent to CCI directly. CCI has no record of receipt of either. This particular issue had been reviewed and denied through the Security Chief's Office in DOC Central Office. CCI staff would have completed documentation for non-delivery had it arrived. There is no reason to believe that staff would not have completed the documentation as we regularly review similar complaints and non-delivery documentation. The evidence presumes censorship to the extent that this examiner is suspect of the documents value.

Inmate complaint of not receiving sue 50 or non-delivery documentation cannot be confirmed. However, it does raise the possibility that inmate Green has sought publication of his writing outside of facility procedures. He is encouraged to review CCI procedure 900.00.01 and ensure that he is following procedure when he is attempting to publish his writing. Copy to Sgt.
