The intended inmate recipient shall receive the same standards as the sender except shall specify the type of violation (mail) and date of the violation with the request for administrative review. If the sender is an inmate and mail is violated, the intended recipient shall not be notified of the rejection and shall not be eligible for an administrative review.
