Pursuant to OAR 291-131-0050, a sender who has received a Mail Violation Notice for written or pictorial content may obtain an independent review of the rejection of correspondence by writing to the Functional Unit Manager or designee at the above address, and requesting an administrative review. A request for an administrative review must be in writing and received within 30 days of the date of the notice, and should specify the reason(s) why the rejection should not be sustained. If the correspondence is returned with the Mail Violation Notice, the rejected correspondence must be sumitted with the review request. If no review is requested, the sender may correct or remove the portion of mail that violates the DOC Rules and send the non-violating mail back to the inmate or proper monies to DOC Central Trust Accounting Unit. The intended inmate recipient shall receive the same standards as the sender except shall specify the type of violation (mail) and date of the violation with the request for administrative review. If the sender is an inmate and mail is violated, the intended recipient shall not be notified of the rejection and shall not be eligible for an administrative review.
