### REASON FOR NON-DELIVERY OF MAIL ITEM

**Note to Inmate:** If denied a mail item, you have the right to appeal using an inmate complaint form DOC-400.

- Mail Privileges between the above individuals have been suspended.
- Item contains contraband.
- Item threatens criminal activity or physical harm to a person.
- Item threatens blackmail or extortion.
- Item concerns sending contraband in or out of the institution.
- Item concerns plans to escape.
- Item concerns an activity, which if completed would violate the laws of Wisconsin, the United States or the Administrative Rules of the Department of Corrections.
- Item is in code.
- Item solicits gifts from a person other than a family member or a person on the offender's visiting list.
- Item contains pornography.
- Item poses a threat to the security, orderly operation, discipline or safety of the institution.
- Is inconsistent with or poses a threat to the safety, treatment or rehabilitative goals of an inmate.
- Item facilitates criminal activity.
- Item contains information that, if communicated, would create a clear danger of physical or mental harm to any person.
- Item teaches or advocates illegal activity, disruption, or behavior consistent with a gang or a violent ritualistic group.
- Item is determined by the warden, on a case by case basis, to interfere with an inmate's penological interests, goals, or needs.
- Item is determined by the warden, for reasons other than those listed on this form, to be inappropriate for distribution throughout the institution.
- Item contains information that if communicated, would create a clear danger of physical or mental harm to any person.

### REASON FOR NON-DELIVERY OF PUBLICATION

If a publication is denied, you may submit a written appeal to the Warden within 10 days of the decision.

- Publication was not received, in its package, directly from the publisher or another recognized commercial source.
- Publication teaches or advocates behavior that violates the laws of Wisconsin, the United States or the rules of the Department of Corrections.
- Publication teaches or advocates violence and presents a clear and present danger to institutional security.
- Publication is injurious as defined in s. DOC 309.04 (4) (c) 8.
- Publication teaches or describes the manufacture or use of weapons, explosives, drugs, or intoxicating substances.
- Publication teaches or describes the manufacture or use of devices that create a substantial danger of physical harm to others.
